BSCC CASE STUDY

The client is a 12 year old, Hispanic Caucasian, female.

She was referred to the clinical department after receiving a forensic exam. The client was brought in by her natural mother.



Over the last six months the client had been sexually abused by her stepfather. While the mother worked in the evening, the stepfather would force himself on her. The client experienced him as threatening and she felt fear and intimidation. She told no one of the abuse believing he would hurt her.

During the last incident of sexual abuse, the step father choked her. In an effort to save her life, she decided that night to tell her mother. The young girl stayed up and waited for her mother to come home. The mother came home, the stepfather was asleep on the sofa. The girl went to her mother's bedroom and disclosed the abuse. The mother immediately made a plan to escape with the girl and drive to the local sheriff's office. During the planning, the stepfather noticed the locked door and conversation in the bedroom and became angry, demanding to be let in. The mother and client ran to the car and got inside. The stepfather followed and physically fought to prevent the mother from getting in the car. The mother states she used all of her strength and was able to shut the car door. They left and drove to the sheriff department.

Treatment started immediately. Children and their families are always met with great support, compassion, and interventions to instill hope. Care is provided at each step through the treatment. A thorough intake evaluation was provided which included trauma scales to ascertain a baseline score. The scores reflected significant severity. The young girl presented with nightmares, difficulty falling asleep, poor appetite, hypervigilance, intrusive thoughts, crying spells, and beliefs that the abuse was her fault. Additionally, she felt responsible for "causing" the mother's relationship with the stepfather to end.

All clinicians at BSCC are certified in Trauma Focused Cognitive Behavioral Therapy (TF CBT). The initial stages of treatment provided psychological education about trauma which include normal reactions to events. The client learned breathing and relaxation exercises and was enrolled in a mindfulness group at the Center. Age appropriate interventions to address cognitions and unhelpful thoughts were provided to work through faulty beliefs about responsibility regarding the abuse. The mother received her own therapy and attended a parenting class to learn best ways to parent, support her child, and address the abuse. The child constructed a trauma narrative through writing about the abuse and created a painting on canvas in the art therapy room.

She was also referred to a Saturday Art Camp day at the Center, complete with fun activities and more skill building. Family conjoint therapy was provided to address the abuse, grooming, ways this stepfather manipulated family members, and reestablish a safe nurturing relationship between the mother and child.

In the middle stages of therapy, the client appeared to smile with ease, have a bright affect, and reported symptom reduction. The trauma scales were readministered and reflected these positive changes and a return to a typical status for a 12 year old child. The end stages of treatment addressed safety issues for the client and the family. The client was educated about safety skills and a safety plan was created. Education and intervention regarding increased awareness and assertive communication, as well as problem solving skills and social skills were provided.

MISSION

The Coalition facilitates the collaboration of organizations within the desert communities by constructing a united response to human trafficking within Eastern Riverside County and surrounding cities. The Coalition aims to approach these issues within a multi-disciplinary approach of committed partners to provide consistent best practices in the fight against human trafficking in the greater Coachella Valley. The Coalition will put an emphasis on local and international human trafficking, which includes sexual exploitation, sex slavery, forced labor, and domestic servitude through awareness, education, service, and advocacy efforts.

PURPOSE

Our purpose is to promote public awareness in our community through education of individuals, student organizations, social and philanthropic clubs, faith-based organizations, medical providers, and key industries about the existence, indicators, and reporting of suspected human trafficking within the Coachella Valley and its surrounding cities.

A few years ago an exhibit of children's art was displayed at Imago Galleries in Palm Desert, courtesy of BSCC Board Member Leisa Austin. Due to the overwhelming response of those who attended, it was determined that the Children's Center needed the exhibit to be experienced by those beyond the Coachella Valley. Hal Gershowitz, Leisa Austin and John Thoresen then worked with the BSCC agency in New York to lay out a plan and build a program that could travel the United States. Hence, Overcame: Art of the Abused Child was born.

The exhibit contains Eighty-four (84) pieces of original art, each created by a victim and survivor of child abuse, and each reflecting the victim's harrowing experiences and ability to overcome them. The title "OverCame" was an original piece crafted by Maleyna Gregorio during a summer Camp Sinatra Art Camp.

At Grand Central Terminal the exhibit was a week-long affair that saw many people spend considerable time viewing the art. Being the first exhibit, the BSCC had therapists on hand to explain art therapy and to sit with attendees who needed to chat about their personal experiences with abuse.

The exhibit was also staffed on a daily basis by representatives from our New York marketing agency. Two special guests were also present for the first couple days of the New York exhibit. Former BSCC client Maleyna Gregorio and her mother attended, along with BSCC partner and abuse survivor from NBC's American Ninja Warrior, Mr. Flip Rodriguez. Flip also was present to autograph his new book about his experience and survival of child abuse.

On November 10, 2022, Petersburg Area Art League (PAAL) opened its doors to the exhibit. Bill Nicholson serves as PAAL's President and commenced the exhibit with a private event for city officials, educators, artists, and professionals in the field child abuse. BSCC Clinical Programs and Outreach Director Araceli Martinez was available at the exhibit to speak about the effectiveness of art therapy and art therapy programs. Through this opportunity, Araceli was able to collaborate with other

Additionally, she had the opportunity to conduct a directive art workshop with a group of 100 African American girls ages 12-17. The girls created self-portraits, gaining insight into self-worth and body image. BSCC Board Member, Beverly Johnson was a wonderful addition to the exhibit. Beverly participated with Bill Nicholson on the Richmond CBS affiliate Morning Program talking about OverCame, Art of the Abused Child and participating in the welcoming party and the PAAL Members only affair the next evening.

The exhibits in New York and Petersburg both had attendance over 1000, and in New York visitors donated over \$5,000 to the Children's Center.
